Applies only to purchases of SLS or Atlas lens control motors (collectively "Eligible New Devices") made at redrockmicro.com and delivered in the United States. You are eligible for the discount shown during your checkout process. Redrock Micro reserves the right to modify the trade-in value offered for Eligible Used Devices during special promotion windows and has no obligation to offer those price adjustments for purchases made outside of any promotional windows. Upon completion of checkout for the Eligible New Devices, your payment method will be authorized for the full retail value of the SLS. The SLS motor and a prepaid return shipping label will be shipped to you using the shipping method you purchased at checkout. You use the supplied box and prepaid shipping label to return your eligible Torque motor to us within 30 days of receipt of SLS motor. When we receive it back and validate an eligible Torque motor, we will refund you \$300 back to the original payment method. Redrock Micro reserves the right to cancel or deny any orders that do not meet the eligibility requirements. You must be the owner of the used device—the Program is not valid on stolen property. Retailers may not participate in the Program by returning in-stock inventory. Redrock Micro will determine authenticity at its sole discretion and ineligible devices may be returned at your expense. You must use the shipping label and follow the guidelines provided by Redrock Micro and Redrock Micro's third-party shipping provider. Redrock Micro will not be liable for any loss or damage to the used device while in transit. Once you have shipped the Eligible Used Device to Redrock Micro, Redrock Micro cannot guarantee its return to you should you change your mind. You acknowledge that it is your responsibility to remove any personal data from your Eligible Used Device before shipping to Redrock Micro. Redrock Micro is not responsible or liable for the removal of any personal data sent to Redrock. Trade-in transactions are final; after you trade in your Eligible Used Device, you cannot get it back.
